#MedSafetyWeek This week is the eighth annual Med Safety Week. It is a social media campaign from the Medicines & Healthcare products Regulatory Agency (MHRA) which aims to raise awareness of how adverse drug reactions (ADRs) can be reported through its <u>Yellow Card</u> reporting scheme. This year the focus is 'Who Can Report?' The MHRA is asking for healthcare professionals to 'Please support the promotion of this important public health message – share, like and repost the <u>MHRA social media posts</u> between 6 - 12 November. Criminal exploitation - how to recognise it and what can I do? The Scottish Government recently published guidance for professionals on Criminal Exploitation. Criminal Exploitation is where an individual or group uses a power imbalance to coerce someone into criminal activity. The multiagency partners involved in Adult Support & Protection in Grampian <u>have created this 7 Minute Briefing</u> (intranet link) which is also attached to the email used to send this brief. This document has been created to give a summary on how Criminal Exploitation links with adults who are more vulnerable and may need support under Adult Support and Protection arrangements. Arrangements during protected learning time (PLT) for GP practices The GMED service will be providing cover during upcoming PLT for GP practices. PLT will take place on the following dates:

- Moray 15 November, 1.30-6pm
- Aberdeenshire 21 November, 1.30-6pm
- Aberdeen City 29 November, 1.30-6pm

In each area, the practices which have chosen to take PLT will be closed, and GMED will provide cover, with the first point of contact being 01224 555 400. This number will **only** be operational on the above dates; after 6pm, patients should call NHS 24 on 111 as normal.

Practices may only close for the times specified and on the relevant date for their area. All practices choosing to take PLT must ensure the above number is shared with their patient population, via waiting room posters, telephone messaging, their website, and any social media accounts.

For those practices not taking part in PLT it will be business as usual.

Dental treatment/training opportunity Aberdeen Dental Outreach Centre is currently inviting unregistered patients for treatment within student teaching clinics. Student treatment, provided within NHS Grampian dental clinics, is free of charge, and is supervised by fully qualified and experienced dentists. If you are over 18 years of age, are not currently registered with a dentist, and are able to

attend appointments during working hours, further information can be obtained by calling Argyll Dental Practice on 01224 551581/ext 51581 or emailing <u>gram.argylldental@nhs.scot</u> An assessment is carried out prior to a patient being accepted to the student clinic to ensure student teaching requirements are matched to patient treatment needs.
