Life 'beyond zero' Following yesterday's announcement from the Scottish Government, we know many of you have questions regarding how the changes to come into effect on Monday 9 August will impact on the workplace, particularly as regards physical distancing and self-isolation. We are awaiting further guidance and will share this with you as soon as we are able. Until then, please keep following all the existing policies and guidance.

COVID-19 vaccination programme The JCVI has today recommended that 16- and 17-year-olds be offered a first dose of COVID-19 vaccine. The UK government has accepted the recommendations and the Scottish Government have indicated they will follow suit. There will be more information to come as this is incorporated into the local vaccination programme.

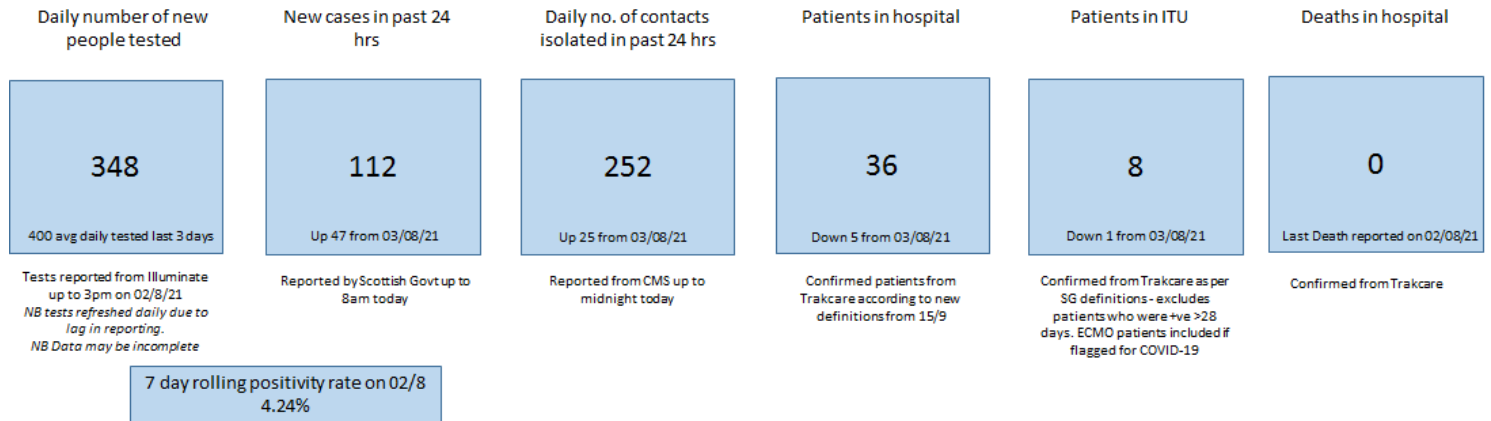
Calling all Orthoptists! Your professional registration matters – don't let it lapse! The HCPC registration period is now open for Orthoptists, with a renewal deadline of **31 August 2021**. Details of other HCPC professions and their registration windows are as follows:

Your professional registration is your responsibility. If you are registered with the HCPC, NMC, or GMC - and your account was registered with your previous NHS.net email address - please ensure your contact details are updated as a matter of urgency. Important information from these bodies, including dates for renewal, may be missed otherwise. Please remember these e-mails may also go into Junk/Spam folders

so check those regularly too. A lapsed professional registration will impact on your ability to work and will most likely result in a disciplinary hearing in line with NHSScotland Workforce policies.

Grampian data Here is the local update for today, including the 7-day rolling positivity rate. As a reminder, this rate is arrived at by dividing the number of positive tests in the past 7 days by the number of tests carried out in the past 7 days. Repeat tests are included in both categories. The figure for the “daily number of new people tested” is only for the number of tests for people who have not been tested previously.

We Care programme – wellbeing webinars A series of webinars have been arranged by the team at the National Wellbeing Hub, to support people working in health & social care to manage their own mental and emotional wellbeing. The hub team are also working to make recordings of previous webinars available through their website, to allow you to view and benefit from them at a time of your choosing.

Child bereavement support workers Two bereavement support workers (jointly funded by The ARCHIE Foundation and the Grampian Child Bereavement Network) are now working across NHS Grampian hospitals.

Carolyn Crews and Jane Watson are available to support families with children up to the age of 18, who have someone they love going through palliative care or have died in hospital. They can attend the hospital and ward with resources like story books, workbooks and information books for parents/carers. This support can be carried forward into the family home if required.

The referral process is quick and easy. First, confirm with the family that they consent to their details being passed on, then contact Carolyn and Jane on 01224 550144 or by email on gcbn@archie.org with the below information,

- Name and relation of the person who has died or is dying
- Name and age of children
- Cause of death
- Contact details for the parent/carer

Carolyn and Jane work on a jobshare basis, with one of them always available Monday-Friday, 10am-4pm. You can also use the contact details about for any queries you have about the service.
