Scam Email Alert: A scam email targeting NHS staff at another health board has been reported. The email contained a suspicious link which if clicked could allow the scammer to gain access to Microsoft 365 credentials. This would allow the scammer to pretend to be genuine NHS staff and if successful, the scammer would be able to view or send emails and download and alter files. If you receive such an email, please do not click on any links within the email. Malicious emails can be reported safely through the following steps on Office 365:

- Right click the malicious email
- Click "Report"
- Click "Report phishing"
- Click the blue "report button"
- Navigate to your "deleted items" folder
- Delete the malicious email from the "deleted items" folder

Malicious emails can be reported safely through the following steps on Outlook Desktop:

- Left click the malicious email
- Click "Report message" on the top row
- Click the "Phishing button"
- Click the blue "report button"
- Navigate to your "deleted items" folder
- Delete the malicious email from the "deleted items" folder.

Inpatient EPR update The Digital Ward Programme will be introducing changes to the TrakCare Inpatient electronic patient record (IP EPR) to support the implementation of Inpatient EPR to Mental Health Services. Further changes are being introduced from feedback received and all changes will be available from Monday (15 July). The key changes are:

• Inpatient EPR screen layout

Change in screen view with a move to a 60/40 screen split to allow more space to review records. (Viewing screen panels can be manually adjusted using the slide bar arrows at the bottom of the screens).

Linked columns in patient timeline to improve the view

Patient Admission Assessment (PAA) tab

Ability for patient distinguishing features to be recorded
Ability to record information regarding home and pet safety
Ability to record named Power of Attorney and Financial Welfare / guardian
Ability to record Dependant information

History Tab

Additional History sections for Personnel and Forensic History Ability to provide details of named professionals involved

MUST Tab

The addition of a Must tab has been included to identify adults, who are malnourished, at risk of malnutrition (undernutrition), or obese. There will be additional questions for the nutrional assessments. The MUST scores will also be displayed within the left-hand pane Observations screen.
