Treatment Escalation Plans (TEPs) update We are making good progress in embedding TEPs for inpatients; currently, around 10% of patients have a TEP recorded on Trakcare, double the rate from last year. We want to encourage everyone to keep building on this. There are lots of tools available to support realistic conversations to inform TEPs:

Procurement fraud can do real damage; if 1% of the annual procurement budget is lost to fraud or error that's equal to a **year's** supply of PPE consumables.

Datix and pressure ulcers – report, reflect, react It is pressure ulcer awareness week; to ensure all incidents are considered, reviewed, and any lessons learned shared with the wider multidisciplinary team (MDT) we have launched a campaign: Report, Reflect, React.

There are several events taking place this week, all related to pressure ulcer prevention and management and all highlighting the crucial role that Datix has in this process. Datix allows us to improve the care provided, but also strengthen professional relationships between MDT members, and has proven to increase staff satisfaction.
