New national clinical management pathway for breast cancer A new Scottish Cancer Clinical Management Pathway has now been published for breast cancer and will be implemented over time by the NHS Grampian Breast Unit. This describes the pan-Scotland consensus on treatment options and supports equity of care across Scotland. It has been developed by clinicians from all three Scottish Cancer Networks and represents clinical consensus on best standard of care for cancer patients within NHS Scotland. **Pilot areas needed!** The Quality Improvement & Assurance Team are working to create a leaflet for patients, families, and carers which gives information on the main ways to give feedback to NHS Grampian about their care and treatment. The leaflet is part of a project which aims to:

- Promote public and staff awareness of the benefits of patient, family and carer feedback
- Increase public and staff knowledge of the options available for patients, families and carers to give feedback
- Improve clarity, understanding and access to the patient, family and carer feedback options available, to enable an informed approach and choice.

The leaflet is currently in its first draft, and we are looking for teams to help test it in their area. Before testing with patients, families and carers we would be interested to hear your comments. As with any improvement project we expect there to be a few rounds of testing before we get a version we could move to the next stage of development with.
