**Social Security Scotland Disability Payments** Since 2021, Social Security Scotland have requested medical information for disability payments, previously known as Disability Living Allowances, directly from health boards. You – we - are obliged to comply with these requests. If you receive a request for information in support of a disability payment, it will come from the Social Security Scotland system, Objective Connect. You input the relevant information into that system. You will also receive an email from Information Governance to let you know that you have a request and to share guidance and training. **Update on Grampian-wide back scanning project** Since NEC Software Solutions came on board to support the roll-out of the back scanning project with our GP practices, medical records are being digitised at pace. This work should be completed by Spring 2025, ahead of schedule, and is proving to be a great example of cross-service working, led by our NHS Grampian Back Scanning Group.

Funding will not allow for all GP practice records across Grampian to be digitised but all health and social care partnerships have been involved in assessing and prioritising this work during the last few years. Funding application packs were shared with each practice to repurpose the space created by the records being scanned, and colleagues in property are working with practices on this using Improvement Grant and possibly Developer Obligation funding where possible. This has been a huge amount of work for everyone involved, so well-done folks!

**Keep up the good work with a Keep Cup!** Congratulations to our catering colleagues who work across all Aroma cafes and stalls, who are helping to encourage a small change that adds up to a big difference. 6.29% of all hot drinks sales were made using a reusable mug during October and they're hoping you can help us boost this even higher over the next few months.
