Agenda for Change 24/25 pay award – payment of arrears and requesting instalments The Agenda for Change 24/25 pay award will be implemented this month and arrears paid in November. If you are employed under AfC and receive benefits, it may be helpful for you have the backdated increase paid to you in instalments. This is something you should discuss with your benefits advisor, but if you do wish to request instalments, this form must be completed and returned by 5 November (intranet link, networked devices only) to gram.payroll@nhs.scot Late forms will only be accepted in exceptional circumstances. Instalments will be split across 3 months/13 weeks depending on your pay arrangements.

Winter vaccinations – staff programme The 'flu and COVID-19 vaccination programme for 2024 has started in earnest – have you booked your appointment? **All** NHS staff, along with workers in care homes for older adults, and social care staff who have direct contact with patients/clients are eligible for a free 'flu vaccination. In addition, all health and social care workers who have **face to face** contact with patients/clients can get a free COVID-19 vaccination.

Both 'flu and COVID-19 are serious illnesses which can result in hospitalisation. Getting the jab (or jabs, depending on eligibility) takes minutes and protects you, the team you work with, the people you care for, and your wider friends and family. As well as being able to book into any of the fixed vaccination clinics in Grampian (in Elgin, Huntly, Macduff, Peterhead, Fraserburgh, Inverurie, Banchory, Stonehaven, and three sites in Aberdeen) there are several dedicated staff clinics on offer. Speak Up week – why inclusion matters As the saying goes, "if you *don't* think that representation is important, you're probably already well represented'. For many of us it's probably hard to imagine what it feels like to not see people like us reflected in certain areas of society or our institutions. Notably, underrepresentation most often exists where decision making takes place. This can result in a negative impact for those who are not part of the conversation and can lead to not all things being created equally.

Disposal of equipment and other non-property assets If you are disposing of equipment or non-property assets belonging to the organisation, you must follow the proper procedures as set out in our <u>Standing Financial Instructions</u> (intranet link, networked devices only). If the asset(s) had a purchase cost of more than £5,000 you are required to notify the capital accounting team. Our external auditors have identified the lack of notification of the disposal of assets as a control risk.

Delays are frequently caused by incorrect completion of the Hazard Identification (ID) Forms received along with the job description.
