Key issues/risks

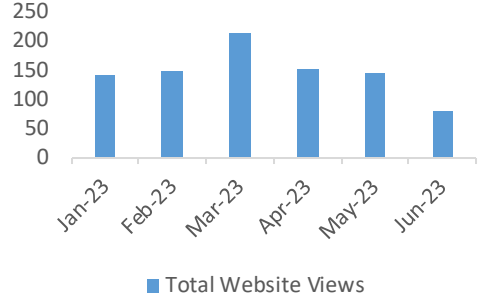
The key risks that pose concern to the programme are:

- **System Pressures** - Workforce capacity and engagement at service level/improvement fatigue remains
- Funding – lack of confirmation re recurring SG funding and non-recurring element for shortfall of Programme Manager
- Staff health and wellbeing
- Public understanding and engagement
- Short gap in current Programme Manager completing secondment and New NMAHP Lead commencing in post
- Delay in information governance process for Value-based referral project

Next steps

- Two-centre conference – link in with colleagues in Orkney
- Acute AHP Leads to undertake SDM Masterclasses
- Widen use of CollaboRATE Tool to evidence SDM
- Lunchtime sessions on SDM, VBHC and Sustainability commencing August 2023
- Value Based Referrals Project -

 - Begin to share data with Progressive Partnership
 - Recruitment drive for focus groups and interviews

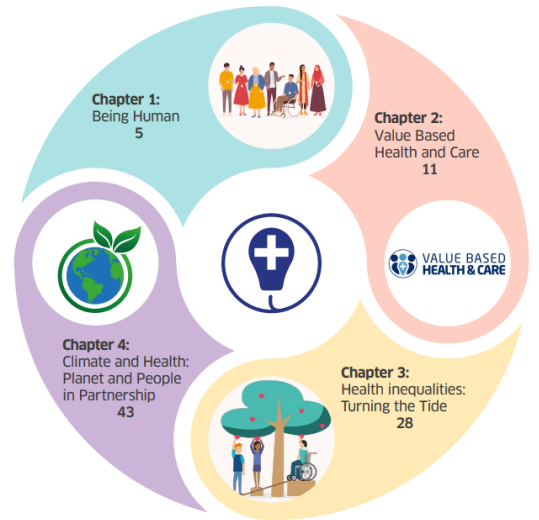
